Dear Visitors,

DAS MINSK Kunsthaus in Potsdam cares for unique works of art. The management of the museums of the Hasso Plattner Foundation exercises domiciliary rights on the grounds and in the museums' buildings. The management may additionally delegate the exercise of domiciliary rights to other persons authorized to do so. Our security staff is required to ensure that the rules are observed. Visitors may be refused entry if there is reasonable cause to believe that they will disrupt museum operations or disturb other visitors. Admission may be further denied if visitors have violated these house rules. They will be barred from entering the premises verbally and in writing. This applies both to visits to the exhibitions and to events held on the premises of the Hasso Plattner Foundation museums. In order for the ban to be lifted, a written request must be submitted with a justification.

We are pleased if you are interested in the artworks in detail. In order to protect the works, we ask you to keep a safe distance from the exhibited objects. A safety alarm and an acoustic signal are triggered when the visitor comes too close. The exhibited works of art may not be touched. For their protection, all indoor and outdoor spaces are under video surveillance.

Backpacks, bags, and outdoor clothing such as jackets pose a safety risk due to their unwieldiness, among other things. Please use the lockers in the basement. Umbrellas, canes, bicycle helmets and similar items are also not permitted in the exhibition spaces. Please use bags to carry your personal belongings, which you will receive free of charge at the ticket counter. Walking aids may be used, of course. No liability can be assumed for the locker room. In the exceptional case that an object or item of clothing cannot be left for a plausible reason, we reserve the right to inspect them.

Photography and filming may be prohibited due to lenders' specifications. In this case, we ask you to observe the corresponding signs. Otherwise, photography for private purposes is permitted without flash and without aids such as tripods or selfie sticks. However, we would like to point out that publication on the Internet or on social media does not constitute private use and that you may be infringing copyrights. Filming and photographing for professional and commercial purposes require written permission from DAS MINSK. Inquiries can be made via email: presse@dasminsk.de.

We kindly ask you to keep your cell phone on silent in the building and not to make any phone calls to enable everyone to have a relaxed visit. You are welcome to make phone calls in the basement and foyer if necessary.

Animals, with the exception of guide dogs, are not permitted in the building. Dogs must be kept on a leash in the outdoor area.

During opening hours there may be temporary closures of exhibition rooms, we ask for your understanding and try to announce these closures as early as possible.

The entire building is barrier free. Upon request, we will be happy to provide you with a loaner wheelchair.

We would be delighted if you brought your children with you! However, children tend to be less familiar with a museum's security requirements. We therefore ask you not to leave children under the age of 12 alone. Please do not carry your child on your back or shoulders in the exhibit halls, but in your arms in front of your body if necessary. Strollers are welcome but will be briefly inspected by visitor services. Upon request, we will be happy to provide you with a loaner stroller.

Food and drinks may not be taken into the exhibition spaces. You are welcome to have a bite in the seating area on the upper level or to visit our gastronomy.

Writing and drawing is only permitted in the exhibition spaces with pencils or colored pencils.

Smoking is prohibited inside the entire building.

In case of fire or other dangerous situations, you must leave the museum immediately through the marked exits without detours. The coat check will not be operational in these instances. The instructions of the security personnel or other persons assigned by the management of the Hasso Plattner Foundation Museums for the evacuation of guests must be followed without fail.
